## INFORMATION FOR THE LOCALLY RECRUITED TEACHERS OF ALL EUROPEAN SCHOOLS

The Board of Governors of the European Schools reformed the Service Regulations for locally recruited teachers in the European Schools. USF, the federation of staff unions of the European and International public service, identifies some progress achieved with this process. However, there are still a number of unresolved issues that call for further action:

- The consultation of the staff concerned has been insufficient. Both statutory representation and union recognition by the employer have been missing entirely.
- Precariousness of employment relationships is remaining.
- Insufficient conformity of internal rules with general labour law as shared by national legal orders, especially labour law based on European Union legislation (EU Directives under Art.151-155 TFEU).
- The availability of legal redress following labour disputes is still very limited. Especially the enforceability of generally acknowledged principles of labour law and of EU legislation is insufficient (the only way to fully achieve this enforceability is to provide for a replication of Art.267 TFEU in the internal legislation).
- Further conflicts with national legislation.

USF addressed the Secretary General of the European Schools, claiming that it is high time for the European Schools to recognize USF as a social partner and to engage into meaningful negotiations and develop concrete proposals. USF is acting side by side with unions affiliated to the <u>European Trade Union Committee for Education</u> ETUCE (in Germany: <u>Gewerkschaft Erziehung und Wissenschaft</u> GEW); the cooperation of the families of unions makes sense in the light of the largely overlapping aims in the interest of the staff members concerned.
